



(REVISED) ADULT HIGH SCHOOL COMPLETION SCHOLARSHIP PROGRAM

I. PURPOSE

The purpose of the Bureau of Women's Affairs *I Nina'metgot Famalao'an* (Making Women Stronger) Adult High School Completion Scholarship Program is to provide an opportunity for women who were unable to complete their high school education, to either earn their high school diploma or GED® high school equivalency. This milestone will enable them to then seek gainful employment (most employers now require a high school diploma), or further their education through a postsecondary program.

II. SCHOLARSHIP AMOUNT AND LIMITATIONS ON AWARDS:

GCC Adult High School Program

Scholarships in the amount of \$500 each will be awarded to a total of eighteen (18) females who enroll in - *or who are already enrolled in* - the GCC Adult High School program, and who graduate from the program by May 9, 2024. A \$500 check will be issued to the graduate by the Bureau of Women's Affairs upon proof of graduation.

GED® (General Education Development) High School Equivalency

Scholarships in the amount of \$500 each will be awarded to a total of eighteen (18) females to enable them to take the GED® high school equivalency test at GCC and pass it by May 11, 2023. The scholarship will pay the \$125 testing fee, plus any re-test fees. BWA will then issue any remaining amount from the scholarship after the GED® fees are paid, to the scholarship recipient in the form of a check.

(Example: GED® test fee \$125 + (2 re-takes at \$11.25 each) \$22.50 = \$147.50, paid to GCC for the recipient to take and pass the test. BWA will then issue the recipient a check for \$352.50 (\$500 - \$147.50)

GCC GED® Fees:

\$125.00 (total for all four content areas)

\$31.25 for each subtest.

Re-test fee is \$11.25 per sub-test or content area for the first two retests.

Subsequent retests are \$31.25 per subtest.

(Please note: DOA check-processing may take several weeks following submission of required documents.)

III. ELIGIBILITY:

Any female Guam resident 18 years of age or older who did not graduate from high school and who wants/needs to earn her adult high school diploma or earn her GED® high school equivalency is eligible to apply.

IV. QUALIFICATIONS & BASIS OF SELECTION:

A. REQUIRED:

1. Applicants must submit a completed application, along with a copy of a valid ID.

NOTE: Upon selection for the scholarship, and if not already enrolled in the GCC Adult High School Diploma program, the applicant will then go to GCC to take the CASAS assessment. If the applicant scores 236 or above on the CASAS assessment, they can register for and take the GED® test. (GCC offers a FREE GED® preparation course that the applicant can take BEFORE they take the GED®.) A score of less than 236 means the applicant will need to enroll in GCC's Adult High School Diploma program and take the required classes, which GCC will help the applicant to determine, based on previous high school history.

- a. Adult High School program students must actively attend and complete all Adult High School classes at GCC*, **and earn a high school diploma by May 9, 2024**, or
- b. GED® registrants must take all required subjects of the General Education Development test (GED®) at GCC and pass **by May 11, 2023**. (Prep courses are available at no cost through GCC.)

**GCC's Adult High School Diploma program is federally funded through the Workforce Innovation and Opportunity Act (WIOA).*

B. RECOMMENDED:

Applicants should show a true desire to complete the GCC Adult High School Program OR take and pass the General Education Development Test (GED®), in order to either secure gainful employment or continue with postsecondary education to earn an associate degree or bachelor's degree. Postsecondary education options can be fully funded through federal financial aid programs available at both GCC and the University of Guam.

C. REVIEW AND INTERVIEW:

A BWA High School Completion Scholarship Review Committee will conduct the initial screening of applications. After a thorough review and assessment of each candidate's information, finalists will be selected. Candidates will be contacted for further information and/or in-person interviews prior to final selection.

D. FINAL SELECTION & AWARD NOTIFICATION:

Scholarship awards will be announced **no later than August 3, 2022.** All selections made by the scholarship committee will be final.

IMPORTANT: While the awardees' names will be announced on August 3, 2022, ***Adult High School Diploma Program scholarship awardees must COMPLETE the Adult High School Program by May 9, 2024, in order to receive the \$500 scholarship.***

GED® scholarship awardees MUST PASS their GED® test by May 11, 2023, in order to receive the remainder of their \$500 scholarship (funding left over after GED® test fees are paid by the scholarship. (Please allow several weeks for check processing to occur.)

V. APPLICATION DETAILS AND DEADLINE:

To be considered, applicants must submit an official application along with the supporting documents listed below to the Bureau of Women's Affairs office at the Office of the Governor at Adelup, or to their village mayor's office. Applications may also be submitted via email to info.bwa@guam.gov.

The official application must be filled in completely and accurately. The complete form consists of:

- Part 1. General Information**
- Part 2. History of Education**
- Part 3. Short Essay**
- Part 4. Certification**

Supporting Document:

- Copy of a valid government-issued photo ID (i.e. Guam Driver's License, Guam ID, Passport, or a REAL ID)

**An application containing information that is false, misleading or incomplete will be disqualified.*

Applications and supporting documents must be submitted **no later than 5:00 P.M. Friday, May 31, 2022.**
